A Message From Your Superintendent



Dear Resident,

This edition of the school newsletter includes the announcement of this year's Distinguished Alumni Commencement Speaker, detailed information about the 2015–2016 school budget, a heartfelt thank you to school board members who have given years of dedicated service to the school and community and an introduction to four district residents interested in serving on the Board of Education.

Detailed information about the school budget can be found on pages 4-5. The school board presents an expenditure budget of \$18,315,472 which represents a 1.23% decrease in spending compared to 2014–2015. This is the third consecutive year in which the expenditure budget has been decreased to reflect the decline in enrollment and funding. Cost saving efficiencies including a shared

superintendent, shared director of technology and other programs and services will not only allow us to work within a proposed budget under the legal tax cap limit, but also one that meets the required 1% equivalent savings on the tax levy. As a result, eligible district residents will once again receive a rebate check to offset increases in school taxes.

We extend a heartfelt thank you to Mr. Ronald Clemens and Mr. Gordon Kenyon for their dedicated service to the school and community. Mr. Clemens served for nine years, most recently as President of the Board. Mr. Kenyon concludes fifteen years of service, including six years as President. We are truly grateful to them for the many contributions each has made to the school and community.

To fill their vacancies, three interested district residents submitted applications to serve as members of the school board: William Moffitt, Virginia Voss and Candice Gancasz. Randall Atwater, a member of the school board for 27 years, is seeking re-election. You can read more about the candidates on page 6.

Distinguished Alumni Commencement Speaker

We are honored to have Mr. David Cleveland address the Class of 2015 at this year's commencement ceremony on Saturday, June 27. Mr. Cleveland, Class of 1967, recently retired from NASA serving as Associate Director for Mission Assurance. His work included many of NASA's robotic missions launched over the past thirty-five years, including the Hubble Space Telescope, Compton Gamma Ray Observatory, Galileo mission to Jupiter, Cosmic Background Explorer, NOAA's weather satellites, astrophysical observatories and earth observing satellites. Mr. Cleveland now serves as a consultant to NASA.

Mr. Cleveland credits much of his success to Barker Central School which propelled him to limitless opportunities. Following high school, he received a degree in Physics from the Rochester Institute of Technology and John Hopkins University in Applied Science. He also joined the US Army and in 1980, took a position with the Naval Research Laboratory's Space Physics Division in Washington, D.C. The following year, he moved to NASA's Goddard Space Flight Center in Greenbelt, Maryland.

We welcome Mr. Cleveland back home to Barker and look forward to his commencement speech.

Qualifications of a Voter

If you are a citizen of the United States; you have been a resident of the Barker Central School District for at least 30 days; you are at least eighteen (18) years of age; you are qualified to register for an election in accordance with Section 5-106 of the Election Law. (NOTE: You are not required to be a registered voter in the general election or to have cast a vote in any such election. You must, however, be qualified or eligible to register to vote.)

You do not have to be a property owner to be eligible to vote.

Candidates for the Board of Education

The Barker Board of Education has three vacant seats for the 2015-2016 School Board election for a three year term each. The candidates that returned petitions are listed here in the order they will appear on the ballot:

Candidate - Bill Moffitt

Bill Moffitt is a 1991 graduate of BCS and has been a resident of the district for most of his life. He is a veteran of the United States Army, attended both SUNY Brockport and Buffalo State for History Education and Political Science and is currently employed by GM Powertrain. Bill has been in a variety of roles for the Barker School system, from substitute teacher to advisor for the Drama Club, and has contributed to many past BCS activities, including the Alumni Committee, English Club, Prom and Homecoming Week festivities. In addition, Mr. Moffitt continues his involvement in the community through the Somerset Little League where he currently coaches and holds a seat on the Board of Directors. His wife, Jackie, is also a BCS graduate, and their two daughters, Piper (Junior High) and Paris (Pratt Elementary), are very active in the BCS sports and music programs and have benefitted from a solid education in Barker as they are both Honor students. It is Bill's hope as a member of the Barker Board of Education that he will be able to help further enhance our children's educational culture and promote our students' community involvement to ensure they are prepared for the challenges and opportunities for life beyond high school.

Candidate – Virginia Voss

My name is Virginia Voss and I am running for Barker school board. My family has lived in the Barker/Somerset area for 15 years and we are active in the community.

My husband, David, is a chemistry teacher at Medina High School and our four children attend Barker. Our oldest, Abby, is a senior, who will be attending Nazareth College in the fall. Ryan is in 10th grade, Ellie in 6th and Aidan is in the 4th grade. I am the Customer Service Manager at Tops in Lockport where I have worked for 27 years. Recently I returned to full time employment after working part-time while raising my family. I am a member of Christ Community Church where I have served on the General Board. I am currently active on the worship team and in children ministries. In my spare time I enjoy reading, baking, cross-stitching and supporting my children in their various activities.

Fifteen years ago my husband and I chose to move our family to Barker so our children would get an excellent education while also enjoying the benefits of living in a small community.
